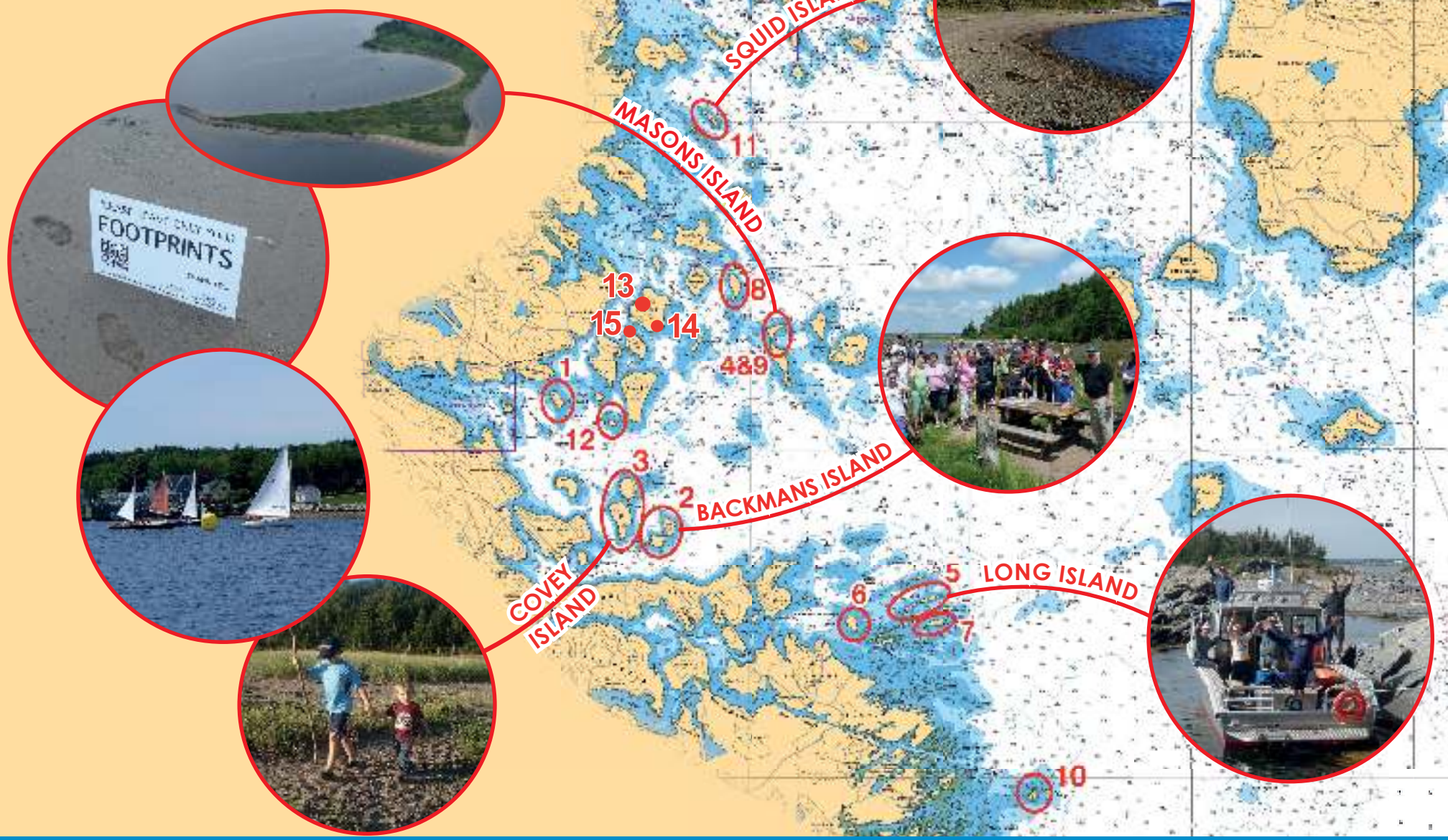

## ISLAND OWNERSHIP

Ownership of acquired islands resides with our major funding partner, the Province of Nova Scotia for all properties with the exception of Mason's northern end which is with the Municipality of the District of Lunenburg.

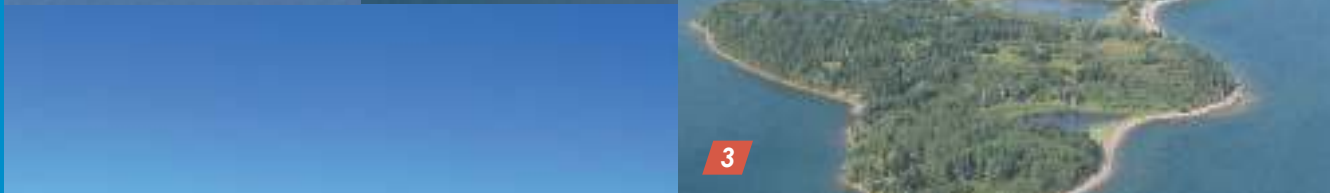
## MICA success to date has been the result of:
